



# ITMA Intensive Trade Mark Transition Course

This course is designed for students who wish to qualify as a Registered Trade Mark Attorney using the new system. The course completes the required law element. Students who pass the course will be able to join the Nottingham Law School (Practice) Course later this year.

This intensive course covers: rules and procedures governing the maintenance and infringement of registered trade marks at United Kingdom and Community levels; international agreements relating to trade mark law; the law relating to unfair trading in Europe and an introduction to the comparative study of the laws of registered trade marks and unfair trading.

Requirements – To attend this course, students must have passed the T1 and Basic English Law foundation examinations, (or be exempt from these). It is not necessary to have passed the T2 or T5 foundation examinations to sit this course, although this is highly recommended. In order to fully benefit from the course, students are also expected to have a minimum of two years of experience.

It is not necessary to have passed the Design & Copyright paper (although passing that paper is still required in order to qualify as a Trade Mark Attorney).

**Fees: £1,800 per attendee** (not including accommodation)
